Legislative Wins with You on Our Team

Together, we are improving protections for animals under the law to ensure their well-being and safety.

✓ Pet Safety and Telemedicine Bills Progress in California

California lawmakers have introduced a bill to help families with pets stay safe during natural disasters and extreme weather events. This bill would require local governments to designate pet-friendly sheltering sites, so families have a safe and comfortable place to go. When forced to flee their homes, people often face an impossible decision: evacuate without their beloved pets or risk sheltering in place to stay together. Since passing the State Assembly, the bill has received unanimous support.

Also passed by the State Assembly is California's veterinary telemedicine bill. While California is a leader in technological innovation, it is one of the most restrictive states in the country for the use of veterinary telemedicine. As the veterinary industry faces a critical shortage of professionals in the workforce, families are struggling to access care for their pets. As we have seen in human medicine, video calls help bridge gaps in care caused by workforce shortages or other barriers to healthcare access. The bill has received bipartisan support from its first State Senate committee.

✓ Farm Animal Confinement Bill Passes New Jersey Senate

New Jersey has passed a bill which prohibits companies from keeping calves and pregnant pigs in extreme confinement, like veal crates and gestation crates. This bill will help ease the suffering of pigs and calves in New Jersey and align New Jersey with 14 other states, including Maine, Massachusetts and Rhode Island, that have banned cruel confinement in some form. Governor Murphy signed the bill into law on July 26.

✓ Pit Bull Ban Repealed in Missouri

The Independence City Council finally voted in favor of repealing a discriminatory dog breed ban that has, for more than 15 years, prohibited people from owning pit bulls within city limits. With the removal of this ban, local Animal Services can better focus their resources on educating communities about pet and human safety, keeping pets and people together and other critical animal welfare issues.
